**Crawford Electric encourages early voting;  
in-person annual meeting set for Sept. 13**

BOURBON – The Sept. 11 deadline is fast approaching for Crawford Electric consumer-members to vote early in the co-op’s director election. All early voters will be entered into random prize drawings for dozens of electric credits, with a grand prize of \$500 worth of free electricity. Members can vote for a director candidate in each of the co-op’s three districts, and they can decide on a bylaw proposition.

Also, consumer-members are invited to attend the 83<sup>rd</sup> annual meeting, which is planned for Wednesday, Sept. 13, at co-op headquarters, 10301 N. Service Rd., Bourbon. Members who haven’t already voted in the director election will be eligible to vote that morning, 8-10 a.m.

“It’s always great to have our members with us for annual meeting,” said Laura Hengstenberg, who organizes the co-op’s member meeting. “It’s also nice to see so many of our members take advantage of our early voting options. We have a simple, robust process again this year.”

Members can vote for one candidate in each of the three district races. District 1 candidates are Janice Dorson, Richard L. “Rick” Adams and Dean C. Brandt. The incumbent directors in District 2 and District 3 are unopposed. Debbie Willette and Joe Cason will each be re-elected to serve another three-year term.

Besides voting for directors, Crawford Electric members will be asked to approve Proposition A, an amendment to the co-op’s bylaws that is designed to protect local control and increase governance transparency. As it was last year, the 2023 annual meeting on Sept. 13 will be a morning-only event with breakfast served from 8-10 a.m. There will be no lunch, and there will be no afternoon session. Entertainment from bluegrass Americana band As the Crowe Flies will occur during breakfast. Attendance prize drawings will also take place that day, mainly between 8 a.m. and 10 a.m. The business session will convene at 10:30 a.m. The meeting will adjourn after the final prize drawing, which is expected to occur no later than 11:30 a.m.

All co-op members received official notice of the meeting in their September *Rural Missouri* magazines. Vehicles will park in fields on the co-op’s 60-acre campus, and shuttles will transport attendees to the garage where the meeting will be held.

Early voting this year opened on Aug. 11 and runs through 11:59 p.m., Monday, Sept. 11. Members who have already requested mail-in ballots should use the provided return envelope to send the ballot back to Survey & Ballot Systems (SBS), the co-op’s independent voting contractor. Members also may vote using a secure online portal, or through the SmartHub account management app. SBS will handle the random drawing for electric credit winners from among all early voters, regardless of whether the member voted by mail, via the website or by using SmartHub.

Crawford Electric Cooperative is a member of Touchstone Energy, a national alliance of locally owned, community-minded electric co-ops with high standards of service. Crawford Electric serves about 20,000 meters along almost 3,000 miles of distribution lines mostly in Crawford, Franklin, Gasconade, Washington and Dent counties.
